**MEMORANDUM OF AGREEMENT
FOR THE RELEASE OF
GOVERNMENT-OWNED OR DEVELOPED SOFTWARE**

1. Distribution of the Graphical User Interface for Output Simulation (IView 2000) is performed by DSIAC on behalf of AFLCMC/EZJA.
2. If requesting IView 2000 for use on a U.S. Government contract, please specify the purpose of the request, contract number, and expiration date. If requesting IView 2000 for use on Independent Research and Development (IRAD), please specify the purpose as IRAD and include your Cooperative Research and Development Agreement (CRADA) number. **For Government employees, please provide a brief reason you will use IView 2000.**

3. The requestor acknowledges that IView 2000 is not to be used for any purpose other than as specified in Paragraph 2.
4. The requestor agrees that they will not release or transfer IView 2000 to anyone without prior written approval from the DSIAC.
5. The requestor agrees to return IView 2000 to DSIAC upon completion of the work specified in Paragraph 2. The requestor may be eligible to retain IView 2000 if there is additional U.S. Government work, including IRAD, or another U.S. Government contract for which IView 2000 is required. Contact the DSIAC for additional guidance.
6. The requestor agrees that they may only use IView 2000 within 3 years of a completed, signed, and valid MOA and within an approved contract's period of performance.
7. The requestor agrees that IView 2000, or any modified version thereof, shall not be published for profit or in any other manner offered for sale to the U.S. Government and shall not be sold or provided to any other activity or firm. If IView 2000 is modified using U.S. Government funds, the U.S. Government maintains unlimited rights to the modifications, regardless if IView 2000 is the basis of, or incidental to, a contract. IView 2000, and modified versions thereof, may be used in the performance of a contract with the U.S. Government but no development charges may be assessed as part of its use.
8. The requestor acknowledges that the U.S. Government is neither liable nor responsible for maintenance, updates, or correction of any defects in IView 2000. Suspected software defects, improvement suggestions, or other change requests should be provided to the DSIAC or recorded directly in the DSIAC Software Change Request (SCR) database for submission to the respective IView 2000 Model Manager and Configuration Control Board (CCB).
9. The requestor acknowledges that receipt of IView 2000 is only for U.S. Government Agencies and their contractors and is export controlled. **IView 2000 shall not be used for, or made available to,**

foreign governments nor shall it be used in any contract with a foreign government without the written approval of the appropriate U.S. Government agencies. Contact the DSIAC for additional guidance.
